## Booz Allen Tech Spinout Acquired by Cisco

MCLEAN, Va.--(BUSINESS WIRE)--Feb. 5, 2025-- [Booz Allen Hamilton](#) (NYSE: BAH) today announced that Cisco has [completed its acquisition](#) of SnapAttack, the cyber threat hunting and detection company [spun out of Booz Allen](#) in 2021. Booz Allen remained an investor in SnapAttack following the spinout.

Created with a vision to help clients stay ahead of new threats and fix key gaps in cybersecurity, SnapAttack was incubated and launched publicly by [Booz Allen DarkLabs](#) —an elite team of cyber operators and defenders inside Booz Allen's [industry-leading cyber business](#) —in 2020. Building on Booz Allen's innovative IP, advanced technology capabilities, and commercial partnerships, the launch helped position SnapAttack for accelerated growth and scale.
